On Thursday, November 2, 2017, a fire at the Father English Community Center completely destroyed the Father English Food Panty and the Used Clothing Boutique. These essential services serve 100 to 150 clients per day or over 4,000 clients per month. The people who rely on the food pantry will go hungry without these important services.

The staff and students who were in the cen-

ter at the time of the fire were all safely evacuated.

As a result of this tragic fire, the community partner of Father English, Eva's Village, has offered the use of their culinary school, which will be used as a temporary Food Pantry. The new temporary food pantry is located at 133 Prince Street, Paterson.

tion in disgrace as a result of having city employees work on personal projects for his family members while still on the city clock and collecting overtime, has been sentenced to 5 9 years in federal prison. In imposing the sentence the judge noted a previous Paterson mayor's similar offense and decid-ed to take this opportunity to send a message to others who may consider taking advantage of their elected position of trust, that this will no longer be tolerated. The judge never did set a minimum term to be served as she imposed the 5 8 year maximum sentence, as set forth in the "plea deal."

Election day 2017 is now just a memory, just another statistic for the record books. So what can we surmise from the ω outcome: In spite of a gallant effort on the part of the Democratic Party, they could not "Flip the 40th". The GOP ticket made up of Senator Kristin Corrado, Assemblymen Kevin Rooney and Chris DePhillips soundly defeated their Democratic challengers. In her acceptance speech, Senator Corrado thanked former Senator Kevin O'Toole and Totowa Municipal leader Peter Murphy, crediting their efforts for the win. . . Most of the other electionvictories went to the Democratic Party who is once again proving to be an almost unbeatable team. . . In Clifton, the response to the only municipal race, that being the race for three seats on Clifton's Board of Education (BOE), got mixed reviews. Incumbent Commissioner Judy Bassford fought back a vicious attack to take first place. Comments were heard all over Clifton in favor of moving the BOE race back to a municipal election day, where the contest would "receive the attention it deserves." There were also many comments on the placement of BOE choices in the voting booth. Many feeling it was hidden and far from the choices for other races.

Residents between Olga B Terr. and St. James Pl. travelling out of the neighborhood are directed to Olga B. Terr. where a traffic officer will regulate traffic.

The Legal Insider What is the "Wrongful Prolongation of Life" By JEFFREY W. POMPEO, ESQ.

In law, a "cause of action" is a series of facts that allow a person to bring a lawsuit against another. It also refers to the legal "theory" upon which a lawsuit is brought (that is, the legal "wrong" the person claims to have suffered), such as breach of contract or medical malpractice.

EXAMPLES

New Jersey case law recognizes a "cause of action" for "Battered-Person Syndrome," that is, anyone involved in a marital or intimate relationship may hold the "dominant" partner liable for damages for inflicting physical or psychological injuries.

A New Jersey statute recognizes a "cause of action" for damages by a "victim" (including a drug user or a parent, child, spouse or sibling of a drug user, as well as, a person injured as a result of the negligent or reckless ac-**Pick up your copy of**

the Jersey Insider at: The Greeting Place Van Houten Avenue Clifton Hawthorne City Hall Lafayette Ave, Hawthorne Like us on facebook! tion of a drug user) against a drug dealer who illegally distributes a controlled dangerous substance (CDS) to the user.

Finally, New Jersey case law recognizes a "cause of action" for damages against anyone who knowingly and negligently exposes a person to a contagious disease, which the person contracts.

In each of these three examples, additional facts must exist to satisfy the requirements of that cause of action.

NEW CAUSE OF ACTION

Recently, a New Jersey court recognized for the first time a cause of action against a hospital and its medical staff for "wrongful prolongation of life" by the estate of a woman resuscitated against her wishes.

DO NOT RESUSCITATE ORDER

Prior to her admission to the hospital with breathing problems, Suzanna Stica had signed "Do Not Resuscitate" and "Do Not Intubate" orders. Despite the orders, she was resuscitated after going into cardiac arrest. For the next six months until she died, she was "intubated, had difficulty breathing, was confined to a wheelchair, had bladder and bowel problems, suffered from depression and dementia, and had trouble speaking."

As a result, the court found that she had experienced pain and suffering and that her "fundamental right to refuse unwanted medical treatment" had been violated.

WRONGFUL BIRTH

Recognizing a cause of action for "wrongful prolongation of life" was, according to the court in the Stica case, a logical extension of the 1979 decision by the New Jersey Supreme Court called Berman v. Allan, which recognized a cause of action for "wrongful birth."

The latter cause of action holds a physician liable to parents for failing to disclose the existence of a medically accepted procedure (known, in that case, as "amniocentesis", which can predict the presence of chromosomal defects) that would have given the parents the option to abort the fetus and terminate the pregnancy of their child born with Down's Syndrome.

NEXT STEP

The Stica case addressed a legal issue that hadn't arisen in New Jersey previously and thus the judge's ruling created "new law"; as such, it's called a case of "first impression." The case will now proceed to trial (unless it is settled by the parties beforehand), at which time a jury will decide whether the hospital and its doctor acted negligently in

still prove its case at the trial.

As time goes on, and life changes and evolves, new causes of action will be recognized by New Jersey courts (called "case law") and by the New Jersey Legislature (called "statutory law").

Maybe it's that I am getting older or perhaps it's just that I seem to enjoy reminiscing

more and more these days about the special birds and people that I have enjoyed over my life's journey. Whatever the reason might be, lately I have begun to think much more about the importance of keeping up my birding journal.

I must confess that I am not much of a list person, even though I know in some birding circles that is frowned upon. Maybe it's because I am just not that organized a person, but creating an actual bird life list seems to me as just a grocery list of birds and not much else.

Now just so you know I do keep a list locked away in my memory ready to look up anytime. If I find the need to recall my first Bald Eagle or Wood Thrush to anyone who is around to listen I just reach back into my memory and tell the story.

I do keep something far more important and personal to me than a list, it's my birding Journal. My journal is a very special book that when I turn the pages, I immediately go back to the woods and fields of days gone by. So whenever I feel the need to recall those very special birds and even better friends I reach for my journal. My journal does definitely contain some writings about many of my firsttime species but for me it is more about my experiences with not only the birds but the people, the weather and maybe even flat tires by the roadside.

My journal is a book that I can go to when I want to reminisce, laugh and sometimes cry. It is my personal document that tells where I have been, what I did and many times what I failed to do. A Birding journal is everyone's life story that finds their hearts and souls renewed by the birds.

Just so you know I don't believe in placing my important bird memories on any Apps or computer program, or for that matter on any tablet and not even my phone. Birding memories are much too important and special to leave on any impersonal electronic device. I firmly believe we need to go old school and put our fingers on a pen and a piece of paper and write down what comes from the heart.

Call me old fashioned and behind the times (My wife often does) but there is still human emotion and feeling in the hand-written word and I would want nothing less to be placed in my birding history than what I felt when I saw my first Barred owl or who I was with when I found an injured Broad-winged hawk. Those are memories that need to be documented and preserved as much as any threatened or endangered species, protected for future generations to be learned from and cherished. No one will be sitting by the fire in an old rocking chair reminiscing and reading your journal on a computer or phone, that won't happen. But on the other hand, your children or grandchildren might pick up your old birding journal one day and relive the birds you saw, the places you've been and the friends you enjoyed being with when you did what you loved most, being in nature with the birds. Your old page worn journal may give them an insight into why you were crazy enough to be out before sunrise, through the snow, ice and rain and maybe just maybe get a hint of what the osprey or peregrine you wrote about actually means to who you are and how far you have come and perhaps get a glimpse into who you truly are as a human being.

Write down your birding story, your history and life in nature. Fot not only yourself to enjoy but one day someone might sit down and enjoy it along with you and also learn from it and treasure it



the same way you do. See you in the Meadowlands -- Don
